

What is the Mobile Food Pantry?

The Mobile Food Pantry is an extension of the WAFER Food Pantry in La Crosse. This program was developed to help bring food to rural families in La Crosse County.

This program provides a free monthly food package to income eligible residents in the Bangor area. Participants receive 3-4 days worth of food.

As part of the Mobile Food Pantry you will also receive a monthly box of food from Channel One. Channel One is a Food Bank that supports the La Crosse Area.

Who Qualifies

- La Crosse County residents
- Monthly income of \$1,771 or less for one person or \$2,391 or less for two people (based on 2013 TEFAP requirements)

A typical food package may include:

- Canned Beans
- Canned Vegetables and fruit
- Macaroni and Cheese
- Dry Pasta
- Tomato product/ Spaghetti sauce
- Tuna or canned meat
- Dry cereal
- Peanut butter
- Canned soup
- Frozen meat
- Hygiene Items

How do I sign up? Where will it be delivered?

To sign up, please fill out the form on the back of this brochure and return it to WAFER. Your food package will be delivered to the Rockland Fire House at 200 S. Commercial St. Rockland WI, on the fourth Tuesday of the month from 6pm to 8pm. Please park and use entrance in the back of the building.
