Faced with choosing between the medications she needed and food, Helen chose the medication. This meant that she skipped meals, which is why she was inquiring about the Mobile Food Pantry.

Fast forward to today...Helen's situation has stabilized and she continues to visit WAFER's Mobile Pantry to supplement her dietary needs, and is able to continue on her medications.

BUILDING CAPACITY, HOPE & DIGNITY CAPITAL CAMPAIGN UPDATE

We are entering Year 2 of the capital campaign to fund our new facility. **We are excited to share that more than 50% of the project has been funded!**


The cost of the total project is \$4.6M, which allows for twice as much space, a location not prone to flooding, features a garage to store delivery trucks (which have been vandalized in the past), has abundant cooler and freezer space to store large donation offers, and most importantly, is a welcoming space for a dignified and personalized shopping experience.

Our solar panels were turned on shortly after the first of the year. The system is projected to supply 50% of our energy needs. These savings will be passed on to serving those need!

Our Executive Director, Erin Waldhart recently wrote: "We have been struggling with inadequate space for years. We had just begun our capital campaign when an opportunity for a larger and better located facility became available...we jumped at it. We are now serving more people than we have in the last five years. Even though we had not completed our capital campaign, we knew it would be the best stewardship of funds to secure the facility and continue on with the campaign."

WAYS OF GIVING TO THE CAPITAL CAMPAIGN

Gifts of cash and/or commitments to be given over a 3-year fulfillment period are welcomed. By using the QR code below, you can make a one time gift or a 3-year pledge.

A tax benefit may be realized by making an IRA Charitable Distribution gift. Individuals age 70.5 or older may consider making a gift through a Qualified Charitable Distribution (QCD). A QCD is a direct transfer of funds from your IRA. These gifts can be counted toward satisfying your required minimum distributions (RMD) for the year. A QCD excludes the amount donated from taxable income.

The maximum annual amount that can qualify is \$105,000. If filing jointly, a spouse can also make a QCD gift from your IRA within the same tax year for up to \$105,000.

WAFER can accept gifts of stock, bonds, or mutual funds. You can transfer stock to WAFER and take a tax deduction based on the market value of the stock at the time of the gift.

You can also make a gift through your **Donor-Advised Fund**.

It is important to contact your donor advisor, accountant, or attorney for guidance when considering one of the tax advantage options.
